#### Point Keeper Committee report – Mary

- We had 80 Horse/Rider combinations actively showing in live shows.
- 36 Horse/rider combinations showing in Virtual.

#### Show Committee Report – Carmen

- Suggested rule changes specific to sanctioned shows/show hosts starting 2024 (some we've already agreed upon, but need to be made official in the rules):
  - Removing the in-person show-host meeting. Replacing with a virtual meeting, or just cancelling the meeting since we are working with established shows.
  - Change show host forms/payment deadline to January 31 of each year
  - Change show bills deadline for omnibus to February 14<sup>th</sup> of each year
  - Change show season to end the last full weekend of September.
  - Remove "support at shows" from the list of show host benefits.
  - Change the technical ambassador verbiage to say available via phone if requested by show host.

- 3.1 Change verbiage to "A GLASS-ED Ambassador will be made available by phone to each show host for each show." (we already agreed to this and it was changed in the show sanctioning info, but not in the rules)
- 3.2 Eliminate all but C (these details should be up to the discretion of the show host, not us)
- 3.3 Eliminate all together (these details should be up to the discretion of the show host, not us)
- 3.4 Eliminate A and B about splitting and combining classes (we should make a rule on how GLASS-ED will handle points for YEA regardless of if classes are split or combined).
- 3.5 Eliminate B (these details should be up to the discretion of the show host, not us)
- Carmen motions to pass rule above changes, Patti seconds. All in favor.
  - Based on the above, we should consider adding/changing "Chapter 4 Year End Awards" Rules to state how we will handle point calculations regardless of combined or split classes.
- Held discussion about Year End Award calculation changes going to send more solid examples in writing to discuss at a future meeting.
