 - Virtual season is completed. A total of 22 combinations are actively showing Live and virtual shows.

Need to Discuss

- How should we handle conflicting show date requests?
 - Do show hosts have first right of refusal on their date until a pre-determined date and then that date is open? Are we still limiting 1 show per day (even with further distances)?
 - Are we OK with having all weekends in a month filled or does this hurt the whole regarding per-show participation?
 - 1 show per day only (regardless of geography). Set date for first right of refusal for current dates. After that date, all remaining dates are open.
- 2024 New Show Sanction Request Rancho Santa Fe Maria Selner
 - Discussion about my findings after a venue visit on 9/1 and how we should proceed.
 - Decided to hold off on sanctioning until a Spring visit to confirm arena is ready. Also, Show Host MUST shadow May Pine Lake Show. If arena is completed sufficiently and shadowing happens, we will late-add.
- Suggested rule changes specific to sanctioned shows/show hosts starting 2024:
 - Removing the in-person show-host meeting. Replacing with a virtual meeting, or
 just cancelling the meeting since we are working with established shows.
 - o Change show host forms/payment deadline to January 31 of each year
 - Change show bills deadline for omnibus to February 14th of each year
 - o Change show season to end the last full weekend of September.
 - o Remove "support at shows" from the list of show host benefits.
 - Change the technical ambassador verbiage to say available via phone if requested by show host.
 - 3.1 Change verbiage to "A GLASS-ED Ambassador will be made available by phone to each show host for each show." (we already agreed to this and it was changed in the show sanctioning info, but not in the rules)
 - 3.2 Eliminate all but C (these details should be up to the discretion of the show host, not us)
 - 3.3 Eliminate all together (these details should be up to the discretion of the show host, not us)

- 3.4 Eliminate A and B about splitting and combining classes (we should make a rule on how GLASS-ED will handle points for YEA regardless of if classes are split or combined).
- 3.5 Eliminate B (these details should be up to the discretion of the show host, not us)
- Based on the above, we should consider adding/changing "Chapter 4 Year End Awards" Rules to state how we will handle point calculations regardless of combined or split classes.

Show Evaluations – Abby

- Show evaluations went out as shows were happening and sent to distribute to about a week after each show.
- Overall good system- Draft email and Carmen sent emails for participants ahead of show to schedule send.
 - o Improvements- Make drafts for all shows at the beginning of the season, have someone cover for fair week/ beginning of Eteam season.

Year End Awards report – Mary

Making arrangements for garment bags and Boot bags for Point and % and embroidered halters for breed award. Ordered 1 boot bag to take to the imprint/embroider shop to see what works best.

Virtual Shows – Patti

- We held virtual shows in the months of May, June, July, and August. Judges were hired for both classical and western divisions from around the country.
- May: 25 classical and 9 western tests ridden; June: 37 classical and 18 western tests ridden; July: 41 classical and 17 western tests ridden; August: 35 classical and 14 western tests ridden.
- 196 total rides @ 20.00 per person Income of \$3920.00 before PayPal fees
- All results were returned to each individual by email (tests and show placings)
 Postage for mailing ribbons and a random test for May/June \$72.19
- July and Aug have not been mailed. Will only mail ribbons so cost will be less.

• Judges fees combined \$1,960 (\$10 per test). An additional pack of 1st-3rd strip ribbons were ordered to complete the year and give us some towards next year.
